## Uinta-Wasatch-Cache National Forest Salt Lake Ranger District

***The Salt Lake Ranger District is seeking a Social Science Specialist / Natural Resources Specialist GS-0101/0401-07/09 (Dispersed Recreation Manager) to fill a Permanent Full-Time Position located in Salt Lake City, Utah! This position focuses on Trails, Wilderness, and Travel Management with strong partnerships and a broad volunteer base.***

**We are looking for experienced recreation professionals that are enthusiastic and highly motivated, that like fast-paced and challenging work environments, and enjoy working with partnerships and diverse communities in a high profile settings!**

**Uinta-Wasatch Cache National Forest:** Located in northern Utah and southwestern Wyoming, the Uinta-Wasatch-Cache (UWC) National Forest encompasses 2.3 million acres of spectacular scenery, unlimited recreation opportunities, nine wilderness areas, seven ranger districts, and borders both rural and urban communities. There are many reasons to select the Uinta-Wasatch-Cache National Forest as your employer of choice! There are opportunities to satisfy your hunger for recreation activities including skiing, snowboarding, snowmobiling, hiking, mountain biking, camping, picnicking, fishing, boating, swimming, and horseback riding. Enjoy cultural events? The majority of the Forest is within close driving distance to theater, arts, cinema, and year-round festivals. You can work in the backcountry during the day and enjoy fine dining in the evening! The Forest is a popular destination for 9 million visitors each year.

**Salt Lake Ranger District:** The district is an "urban" forest where more than a million people reside in the adjacent Salt Lake, Davis and Tooele Counties. The annual snowpack is both an important source of water for local communities and a draw for skiers and snowboarders enjoying the "Greatest Snow on Earth." The District's proximity, scenic beauty, and year-round recreation opportunities means that it is a beloved and busy place. The district office is located in the City of Cottonwood Heights, a suburb of the Salt Lake City Metropolitan Area, and is responsible for the management of 4 Wilderness Areas, 4 ski areas, and spectacular recreation opportunities. There is a wide array of housing types for rent or purchase within easy commuting distance to the office.

### **Duties of the position include:**

- Operation and maintenance of the district trails and travel management system, signs, 4 Wilderness Areas, and Winter Recreation (particularly camping and facilities for backcountry skiing and snowmobile recreation).
- Oversight of volunteer service agreements, partnership agreements, and challenge cost-share agreements with our partners, including Salt Lake County, Cottonwood Canyons Foundation, and Salt Lake Climbers Alliance to name a few.
- Funding for crew work is based on extensive partnership coordination with a variety of stakeholders on projects with duties including developing collaborative projects, working with others to seed funding opportunities, and implement funded projects.

- Recruitment, hiring, and supervision of 2 permanent employees and a large seasonal workforce.
- Responsible for planning, implementing, and monitoring construction, blasting, and other similar projects. Serves as a COR (Contracting Officer's Representative).
- Utilizes databases to improve work flow - such as WorkPlan, NRM/Iweb for INFRA, eTracker, & Paycheck 8 and has budget oversight with emphases on tracking and oversight.
- Works closely and coordinates with Developed Sites Recreation Manager.
